- 2025 Maintenance

- Tríona Cosgrave reported there are currently 2 homes who have not paid their 2024 Fees.
- Tríona Cosgrave reported there are currently 22 homes who have not paid their 2025 Fees
  - They are now in collections with Field Law.
- Tríona Cosgrave confirmed the GICs have been invested at \$120,000.
